Ferric Nitrate, Nonahydrate (7782-61-8), 3-4%.

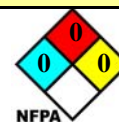
Water (7732-18-5), 97-96%.

**Section 4: First Aid Measures***Always seek professional medical attention after first aid measures are provided.***Eyes:** Immediately flush eyes with excess water for 15 minutes, lifting lower and upper eyelids occasionally.**Skin:** Immediately flush skin with excess water for 15 minutes while removing contaminated clothing.**Ingestion:** Call Poison Control immediately. Rinse mouth with cold water. Give victim 1-2 cups of water or milk to drink. Induce vomiting immediately.**Inhalation:** Remove to fresh air.
